# **New Class of Child Protection Specialists Begins Training**

As part of the Division of Children and Family Services goal to reach full staffing levels and better protect the children of Cuyahoga County, a new class of 18 Child Protection Specialists began training November 27th. These new workers will go through 12 weeks of intense training and shadowing. Next, the workers will have an 8-10-week transition period when they'll start to receive a small number of cases while being coached and mentored by experienced Transition Supervisors. Additional CPS candidates are being reviewed with hopes of bringing in another training class of workers in early 2019 to fill the remaining vacancies.

# **Canopy Child Advocacy Center Opening**



We are excited to announce the opening of the Canopy Child Advocacy Center (CAC). A Child Advocacy Center is a one-stop location where children and families impacted by child abuse can get a full range of services in a child-friendly and trauma-informed setting. A multi-disciplinary team coordinates work regarding child safety, forensic interviews, law enforcement, medical exams, mental health, prosecution, and victim advocacy. At first, the Canopy CAC will provide services to children under 12 years old who live in the City of Cleveland and for whom there is concern

they have been sexually abused. As the Center builds capacity to serve more children, the referral criteria will be expanded. The CAC is a collaboration between several agencies including:

There are more than 500 children in the permanent custody of Cuyahoga County. More than 200 of them need a forever family. Children range in age from infants to 17-year-olds and come from a variety of backgrounds. Many have siblings also up for adoption, and several children have special needs. ## Pronoun Buttons Available for All DCFS Clients, Partners & Staff

As part of the division's effort to improve the well-being of youth who self-identify as LGBTQ, pronoun buttons are now available for anyone working with DCFS. Using a person's



chosen pronoun is a critical way of recognizing and respecting a person's gender identity or expression. The pronoun buttons are part of the AFFIRM.ME program. The AFFIRM.ME program is a set of services developed specifically to improve the lives of LGBTQ2S youth in foster care through Safe and Confidential Identification, the Pride Caregiver Network, and Chosen Affirming Families. #### Harvard Community Services Center added as Neighborhood Collab

Effective November 19, 2018 the Harvard Community Services Center has been added to the list of DCFS <u>Neighborhood Collaboratives</u>. DCFS has contracted agreements with ten organizations operating 13 collaboratives county-wide. These neighborhood -based organizations provide resources and support for families to prevent their involvement with DCFS. They also work with families that are already involved with our agency by offering support to stabilize family dynamics and return or maintain children safely at home. Collabs also serve as a community voice, advocate and resource on behalf of children's well-being, often working with DCFS staff to identify best options to help insure child safety and permanency.

Murtis Taylor Human Services System - The Southeast Community Based Services Program Garfield Heights

The Southeast Community Based Services (CBS) program of lead agency, Murtis Taylor Human Services System (MTHSS) is open 9:00am – 5:30pm Monday through Friday and after hours by appointment. The team at the CBS holds more than 20 years of experience working with families in the community and collaborates with 15 community partners to provide programs and services to families. Families are also linked to MTHSS programs and services such as Youth, Family including fatherhood support and parent education, Senior Services, Behavioral Health and Addiction programs and services as eligible. Also, each quarter MTHSS hosts the following programs to address Child Safety, Infant Mortality and Educational Neglect:

- Car Seat Safety with partner, Rainbow Babies and Children's Hospital
- Safe Sleep Education with partner, Cuyahoga County Fatherhood Initiative
- Clothing and Book Bag distribution with partner, Shoes and Clothes for Kids

The CBS program works with families by wrapping supports around them using a Case Management Model for assistance with food referrals, Ohio Benefits enrollment, referrals to Employment Connection, Kinship Caregiver Support and other supports as needed. The priority is assisting families to prevent children from experiencing abuse and neglect. Community Meetings are held the 3rd Thursday of the month to share resources and educate the community and providers on resources available right in the community.
